ORDER

THIS MOTION, made by the Petitioner for an Order for:

1. Interim joint custody of the children of the marriage, namely, Meaghan Elizabeth Harvey, born May 15, 1986 and Jonathon Peter Harvey, born January 29, 1990;
2. Interim support for the aforesaid children in the amount of \$750.00 per month per child;
3. An interim Order requiring the Respondent to maintain health medical and dental coverage for the benefit of the Petitioner and children;
4. An interim Order restraining the Respondent from depleting any property under his control and requiring him to preserve all such property until further Order of this Court;
5. An interim Order for exclusive possession of the matrimonial home municipally known as 299 Warden Avenue, Scarborough, Ontario

6. Costs on a solicitor and client basis;

and this CROSS-MOTION, made by the Respondent for an Order for:

1. Interim joint custody of the children of the marriage;
2. An Order opposed to the amount of interim support requested by the Petitioner;
3. An interim Order restraining the Petitioner from depleting any property under her control and requiring her to preserve all such properties until further Order of the Court;
4. An interim Order prohibiting the Petitioner from having Rick Pinto occupy the matrimonial home on any overnight basis and prohibiting the Petitioner from having tenants or borders in the home;
5. An Order prohibiting the Petitioner from leaving the infant children in the care or control of Rick Pinto,

were heard this day at Toronto.

ON READING the Notice of Motion, Affidavit of the Petitioner sworn October 4, 1991, Supplementary Affidavit of the Petitioner sworn December 6, 1991, Financial Statement of the Petitioner sworn August 8, 1991, Cross-Motion, Affidavit of the Respondent sworn November 11, 1991, Supplementary Affidavit of the Respondent sworn December 3, 1991, Financial Statement of the Respondent sworn November 17, 1991, Affidavit of Carol Cameron sworn December 3, 1991,

1. THIS COURT ORDERS, on consent, that the Petitioner and Respondent shall have interim joint custody of the children of the

marriage, namely, Meaghan Elizabeth Harvey, born May 15, 1986 and Jonathon Peter Harvey, born January 29, 1990, with the children having their primary residence with the wife.

2. THIS COURT ORDERS, on consent, that the Respondent shall have interim reasonable and liberal access to the aforesaid children on providing twenty-four hours' notice.

3. THIS COURT ORDERS, on consent, and on an interim basis, that the Respondent shall maintain, for the benefit of the Petitioner and children, health and dental coverage as is currently in place with his employer.

4. THIS COURT ORDERS, on consent, and on an interim basis, that both the Petitioner and Respondent shall preserve all property currently in their possession until further Order of the Court.

5. THIS COURT ORDERS, on consent, and on an interim interim basis, that the Respondent shall pay child support in the amount of \$1,200.00 per month, commencing November 14, 1991, and that the husband shall receive a credit for child support monies paid to date, and the issue of child support shall be adjourned for purposes of cross-examinations.

6. THIS COURT ORDERS that the husband shall not attend at the matrimonial home save for purposes of access, or such other errands only after providing the Petitioner with twenty-four hours' notice.


7. THIS COURT ORDERS that the issue of exclusive possession of the matrimonial home is adjourned pending cross-examinations by the parties on material filed and to be filed, if so advised.

8. Unless this Support Order is withdrawn from the Office of the Director of Support and Custody Enforcement, it shall be enforce

by the Director and amounts owing under the Support Order shall be paid to the Director, who shall pay them to the person to whom they are owed.

This Order bears interest at the rate of 10.00 % per year on ar payment or payments which are in default.
